# Our history

This is a story that started in the city and region of Antofagasta, in the heart of the mineral-rich desert of Northern Chile, where Andrónico Luksic Abaroa used to drive alone with his pickaxe and mining helmet, searching for a copper vein, searching for opportunities.

During the second half of the 20th century, the Luksic family gradually transformed itself into one of the most dynamic economic groups in Chile's history. Currently, the Group has business activities in 129 countries through different companies and industries and is one of the top ten copper producers worldwide. It also has substantial ownership stakes in various business sectors such as finance, manufacturing, energy, transportation, port services, beer, wine and other beverages.

Andrónico Luksic Abaroa (1926-2005), was born in Antofagasta, a city in Northern Chile over 1,300 kilometres from Santiago, the nation's capital. He was the son of immigrants, and through hard work and determination he started to build up the Luksic Group. The vast Atacama Desert that surrounds the arid city where he was born left a deep imprint on his childhood and influenced his career path. The world of mining became one of his callings.

During the 1950s, Mr. Luksic Abaroa began to explore Northern Chile in a pickup truck with a pickaxe in hand. His entrepreneurial spirit drove him to seek new opportunities that decades later transformed his enterprise into the ninth largest copper producer

in the world. Simultaneously, he also created a leading financial and industrial holding company, and developed a hotel business in Croatia, the land of his roots and ancestors.

However, he did not achieve all these endeavours on his own. Andrónico Luksic Abaroa fathered five children: three sons and two daughters. From an early age, he groomed his three sons for involvement in the family's companies and each took on a leadership role in one of its lines of business. His firstborn, Andrónico Luksic Craig, took charge of the financial sector. His second son, Guillermo Luksic Craig (1956-2013), led the industrial sector, while Jean-Paul Luksic Fontbona managed the Group's mining activities. Together they triggered significant growth in the Group's assets that started in the 1980s and has continued to this day.

"We are a product of Chile's success" is a phrase that has been repeated countless times by second-generation Luksic Family members, referring to the Group's successful growth. The country's economic expansion over the last few decades has undoubtedly been a key factor in the emergence of a large group of entrepreneurs and dynamic commercial activity in Chile.

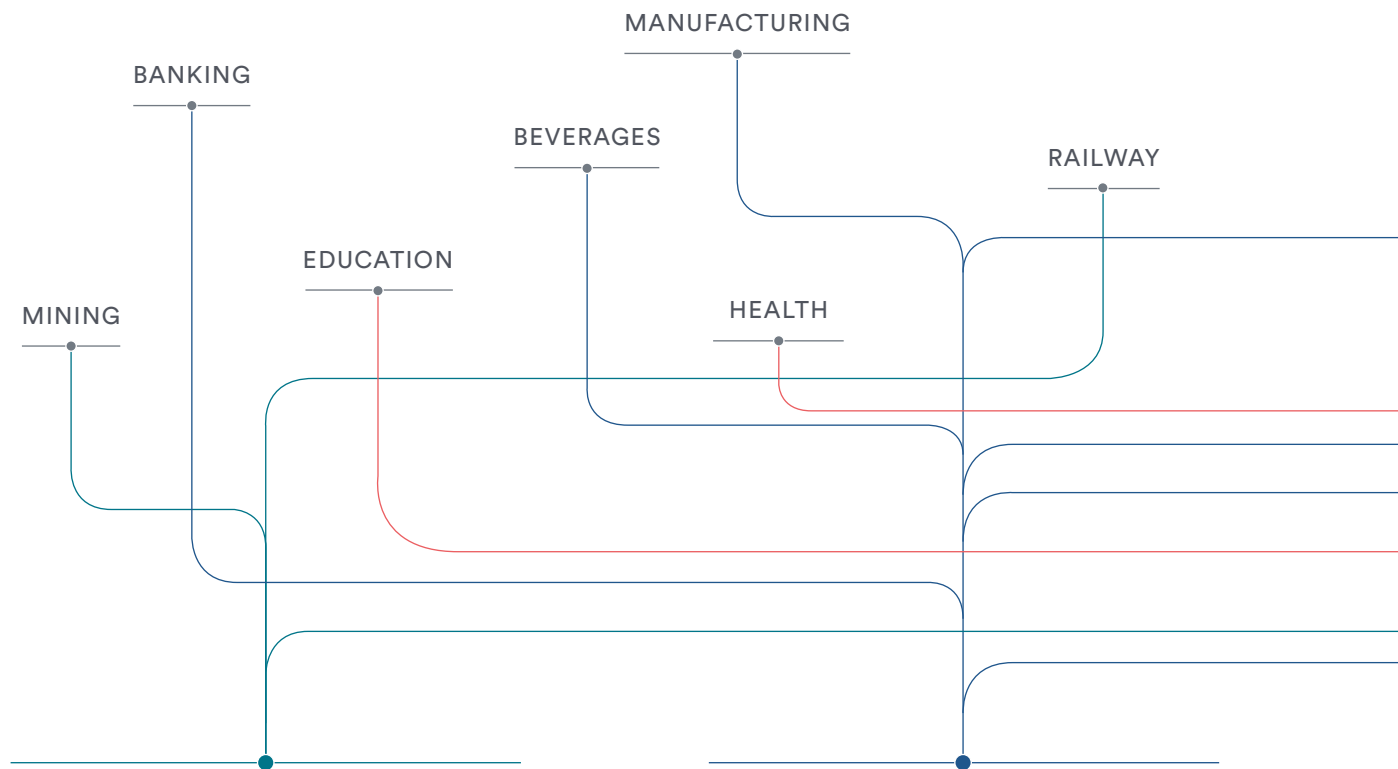

The Luksic Group has been in existence for nearly 70 years, and throughout this period it has maintained intact three core features that have become hallmarks of the Group. The first was the desire to become a high-stakes global conglomerate. At present, the Group's companies have business activities in over one hundred countries, thereby reaffirming its strategy of international diversification. A second characteristic, right from the Group's beginnings, has been to seek out world-class strategic partnerships in the mining, financial and industrial sectors. The Luksic Group has a high percentage of partner participation in companies, with partners generally contributing their experience and knowledge of state-of-the-art technologies. Lastly, the founder's vision was to diversify activities into different productive sectors, a strategy that continues to this day as a unique trademark.

The Luksic Group is currently present in diverse economic sectors through two of its holding companies: Quiñenco S.A. (industrial and financial, led by Pablo Granifo Lavín) and Antofagasta PLC (mining, led by Jean-Paul Luksic Fontbona). A third business area is focused on the tourism and real estate sector

in Croatia (led by Davor Luksic, one of the grandsons involved in family business activities or social foundations).

In addition to creating and managing leading companies in Chile, Andrónico Luksic Abaroa and his family have always shown deep commitment to social progress. They have established nonprofit organizations to contribute to Chile's development and help solve social challenges. The Luksic Foundation is currently the family's main charitable organization, and, during the final years of his life, this is where Mr. Luksic Abaroa dedicated most of his time and effort. The Foundation seeks to help provide equal access to high-quality education for children in underprivileged areas throughout Chile. After Andrónico Luksic Abaroa's death, his family expanded his philanthropic legacy by founding other nonprofit organizations in Chile. One of these foundations is named after Guillermo Luksic Craig, who sadly passed away in 2013.



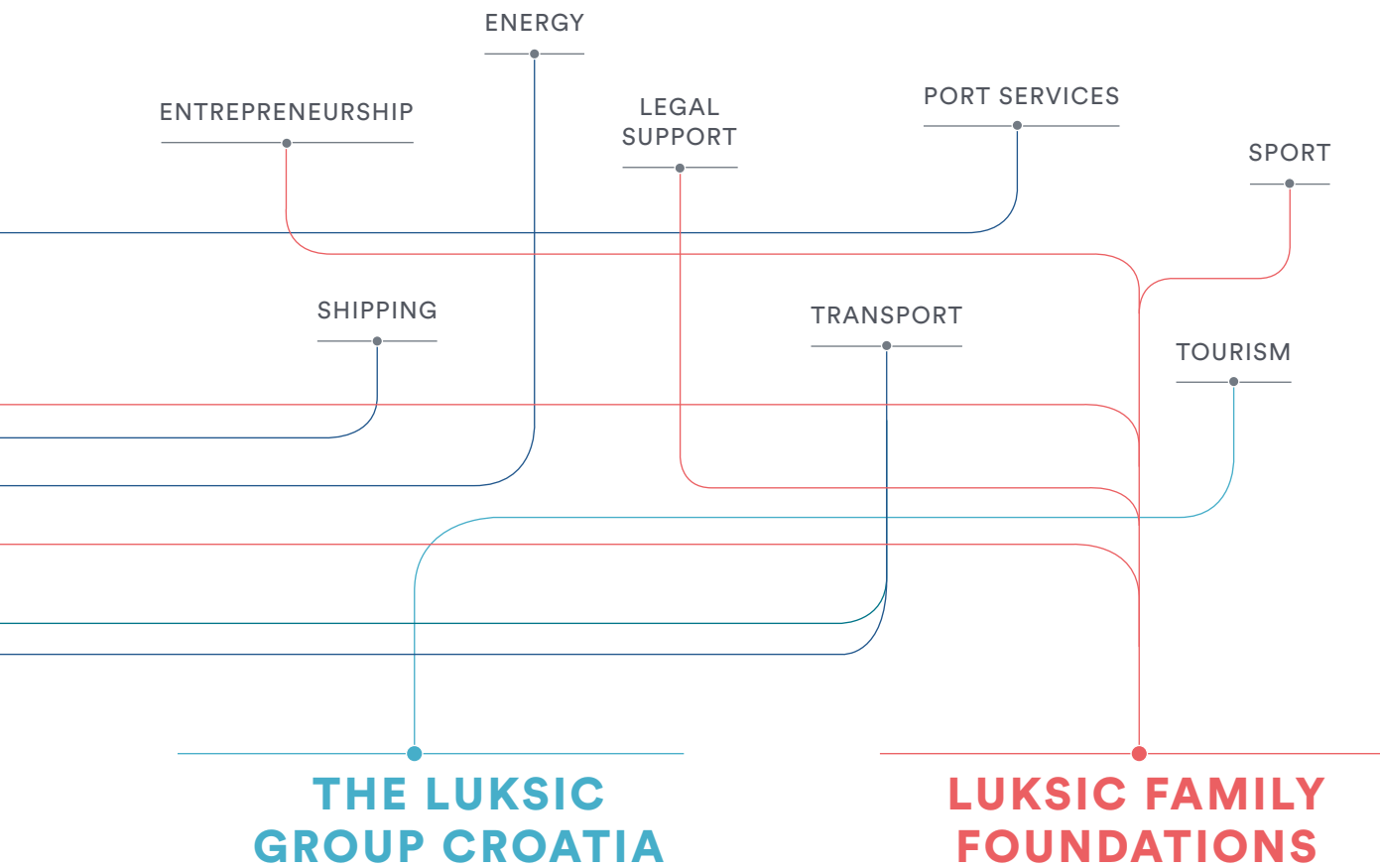

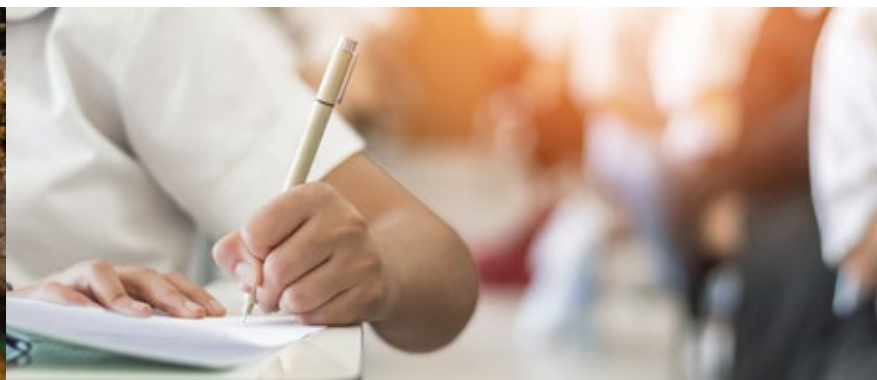
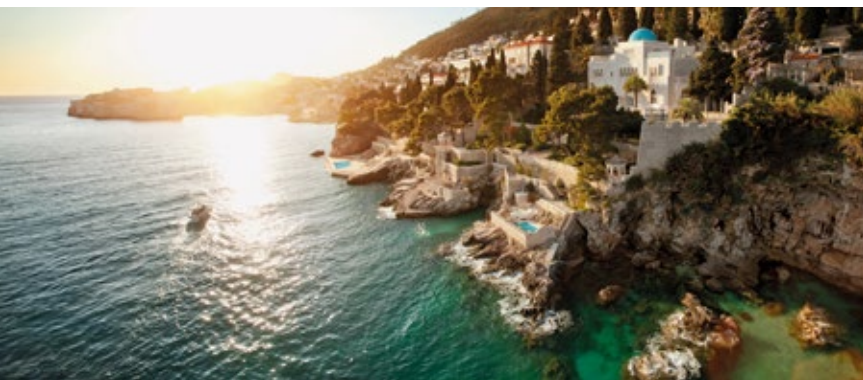

Antofagasta PLC is the leading Chilean publicly listed mining group and one of the largest copper producers in the world.

Antofagasta PLC's story began with the Antofagasta (Chile) and Bolivia Railway Company limited, which was listed on the London Stock Exchange in 1888. In 1980, the Luksic Group acquired control of the company and in 1982 Antofagasta Holding PLC was created (renamed Antofagasta PLC in 1999).

Since then, the company has grown to become one of the ten largest copper producers in the world. Today, mining is the company's core business, representing over 98% of revenue and EBITDA. Antofagasta operates four copper mines in Chile: Los Pelambres, Centinela, Antucoya and Zaldivar, two of which produce significant volumes of by-products. The company also has a portfolio of growth opportunities located mainly in Chile. In addition to mining, the Group has a transport division providing rail and road cargo services in northern Chile, predominantly to mining customers, which include some of Antofagasta's own operations.

In addition to mining operations in Chile, the company also has its sights set on international expansion. It seeks to find new ore resources in countries such as Peru, Canada, and the United States. The quest for growth has led to the development of a copper, nickel, cobalt and PGM project in Minnesota, USA. Additionally, the Company participates in the ownership of Compañía de Minas Buenaventura S.A.A., the largest publicly traded precious and base metals company and a major holder of mining rights in Peru.

Antofagasta PLC's shares are traded on the London Stock Exchange under the ANTO stock symbol, and its shares are a constituent of the FTSE100 index.

Chile is the largest copper-producing country in the world, with 23% of global copper reserves lying beneath its soil and a reputation for high mining standards. Antofagasta PLC is the only Chilean publicly-listed mining group operating in the country's large-scale copper industry, alongside multinational players and the state-owned company Codelco.

Antofagasta PLC is consistent with the Luksic Group's preferred business model. The basis of the model is to build partnerships with companies that own from 30% to 50% of their mines, with the operation and management of the deposits remaining under Antofagasta PLC's control.

## We generate positive changes by paving the way for the future of mining

Human capital is the group's most valuable asset. For this reason, its first priority is to protect the life, health and wellbeing of its workers, as well as of those who live in communities near group operations and project sites.

Antofagasta PLC has a team of first-class professionals and aims for excellence in everything it does; this has become the group's undeniable trademark. Antofagasta PLC has a long-term vision, yet understands that challenges must be faced with courage in order to learn from mistakes and have the flexibility to adapt to new realities. It is a pioneer in the use of untreated sea water for copper production and was the first group in the industry

to apply thickened tailings technology on a large scale, thereby reducing water consumption.

The company already has a desalinization plant operating at its Los Pelambres operation and, once its capacity has doubled, it expects 90% of the water it uses for copper production to be seawater or recirculated water. Furthermore, Antofagasta PLC promotes the use of renewable energy in order to cut back on emissions that negatively impact the environment. Its four mining operations rely solely on energy generated from renewable sources.

## GENERATION OF OPPORTUNITIES FOR COMMUNITIES AND REGIONS

**A total of US\$ 48 million** was allocated to corporate social responsibility in 2024 in order to promote community investment programmes and social projects. This included donations, sponsorships and financing of the Minera Los Pelambres Foundation.

## INNOVATIVE SOLUTIONS IN WATER USAGE

**Around 58%** of all the water withdrawn for use in the group's operations in 2024 was seawater. The group is a pioneer in the use of untreated sea water for mining, dating back to 1993.

## JOB CREATION

Antofagasta employs some **29,800 people**, of whom 27% are own employees and 73% are contractors. Antofagasta's People Strategy is built on four pillars: culture, talent management, organisational effectiveness, and labour relations and engagement.

## PROMOTING RENEWABLE ENERGY

Los Pelambres completed the construction of a desalination plant and has plans to double its current capacity. Once completed, this will result in **over 90% of its water** usage coming from desalinated sea water and recycled water.

## PROMOTING PRODUCTIVE CHAINS

**Over 4,000 suppliers** of goods and services form part of Antofagasta's supply chain, of whom 93% are based in Chile.





# LOS PELAMBRES

The production facilities of Minera Los Pelambres stretch across 120 kilometres between the Andes Mountain Range and the Pacific Ocean, in the Choapa Province in the Coquimbo Region. It is a sulfide ore mine that began operations in 1999. It produces copper concentrate (with gold content) and molybdenum concentrate, through a grinding and flotation process.

The ore is extracted from an open-pit mine located in the Salamanca district, roughly 240 kilometres northeast of Santiago, and is shipped out via the Punta Chungo port in Los Vilos.

Antofagasta PLC is the operator and controlling shareholder with 60%, and a consortium of Japanese companies, consisting of JX Nippon Mining, Mitsubishi Materials, Marubeni, and Mitsubishi Corp, owns the remaining 40%.

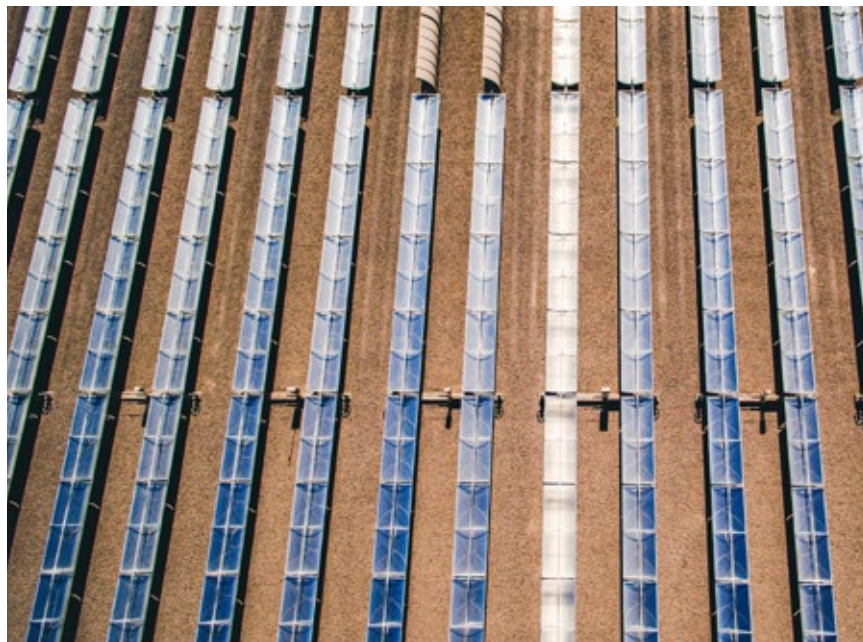
# CENTINELA

As part of its efforts to ensure company growth, the group created Minera Centinela in July 2014 by merging El Tesoro and Esperanza's operations. The mine is located at 2,300 metres above sea level in the Sierra Gorda district, an important mining area in the Antofagasta Region.

The mine property contains both sulfide and oxide copper ores and produces gold as a by-product. In 2018 it also began producing molybdenum.

For water resource conservation purposes, the company largely operates with sea water and was the first mining company in the world to use thickened tailings technology on a large scale.

Antofagasta PLC owns 70% of the property and the remaining 30% is owned by the Marubeni Corporation.

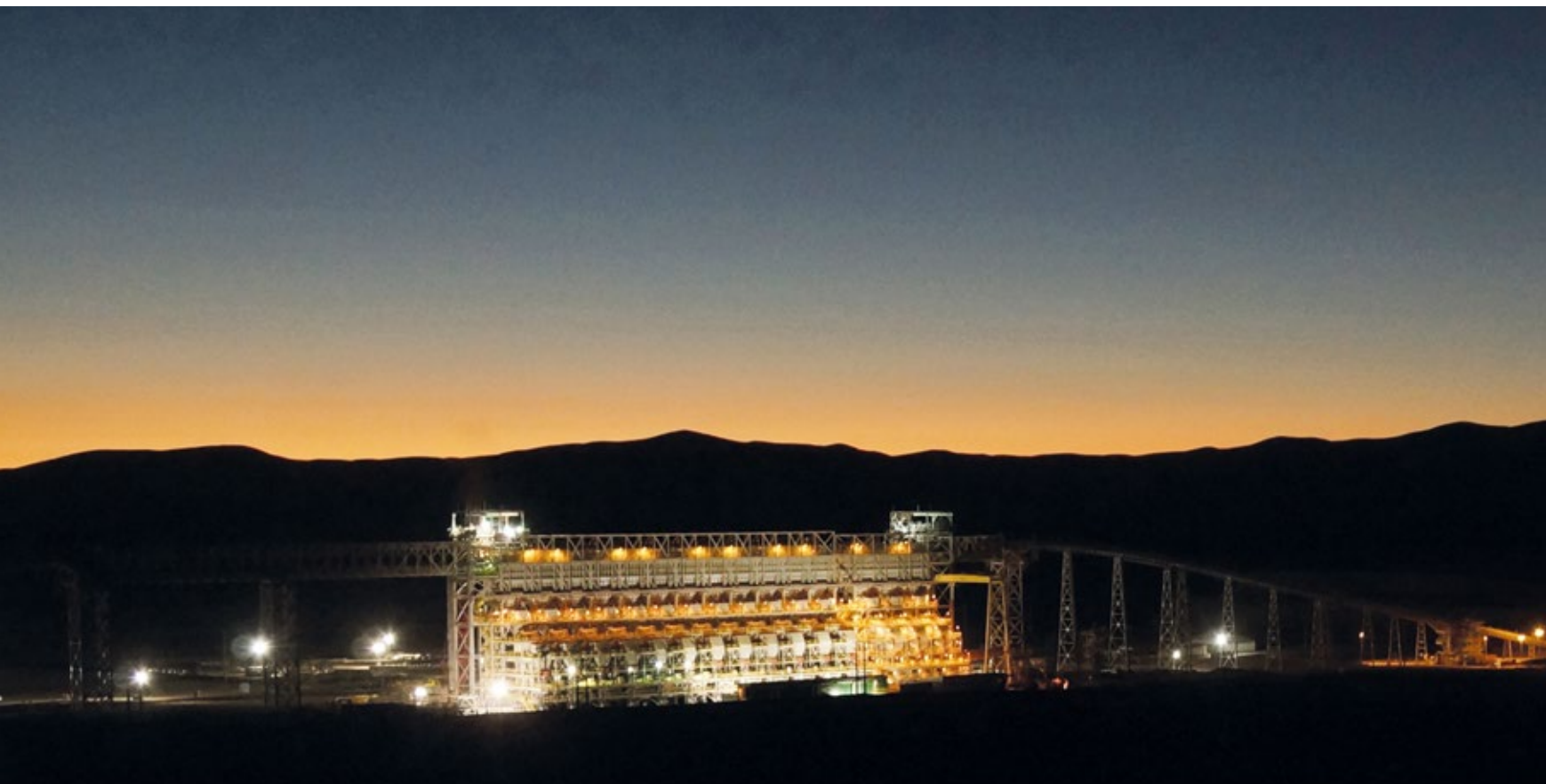


# ANTUCOYA

---

Antucoya, a copper oxide mine, is the group's newest operation. It is located in the Antofagasta Region, between the Maria Elena and Mejillones districts, at 1,700 metres above sea level. It began commercial production in April 2016. The mine operates exclusively with untreated sea water, extracted from facilities immersed in the

Michilla Cove. Given its low ore grade (an average of 0.35%), this operation faces efficiency and production challenges, which will be a common issue in future mining operations. Antofagasta PLC owns 70% of the mine's property and the remaining 30% is owned by its strategic partner, the Marubeni Corporation.

Therefore, in December 2015 it acquired 50% of the Zaldívar Mining Company from Barrick Gold Corporation, thus transforming this 20-year-old operation into a new asset. With this transaction, the Group also became the mine's operator. The deposit is located in the Antofagasta Region, at over 3,300 metres above sea level.

FCAB is a key player in the development and growth of the Antofagasta Region. It provides integrated, multimodal and operational services with over 700 kilometres of track, and it has trains with hoppers and tank wagons, in addition to a fleet of trucks with state-of-the-art technology capable of transporting products from the largest mines in Northern Chile. Currently, FCAB transports sulfuric acid, copper concentrates, anodes, cathodes, brine, lime, solvents and fuel. FCAB also transports zinc and lead concentrates from Bolivia, and minerals to and from the ports of Antofagasta and Mejillones.

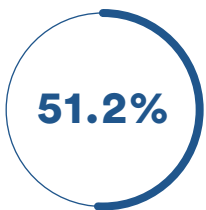

The Compañía Sud Americana de Vapores, CSAV, in which Quiñenco holds a 66.5% stake, is a Chilean company with a track record spanning more than 150 years. Since December 2014, it has been one of the largest shareholders of the German shipping and container transportation company, Hapag-Lloyd.

Hapag-Lloyd was established in 1847 and is one of the world's foremost container shipping companies. Its headquarters are located in Hamburg, Germany, which is the hub for a network of 139 countries around the world. The company has a modern fleet of 299 vessels.

After its 2017 merger with United Arab Shipping Company (UASC), Hapag-Lloyd became the fifth largest container shipping company in the world. The synergies achieved through this merger also made it one of the most efficient shipping companies worldwide.

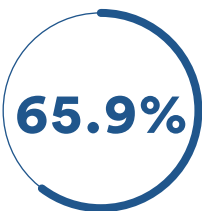

Enex was acquired in 2011 and inherited almost 100 years of Shell's legacy in Chile. In 2018, the Company kick-started its international expansion by acquiring Road Ranger, the fourth largest travel center network in the United States. A year later, it entered Paraguay, acquiring Gasur SRL, a local service station network.

Enex has established itself as a premier supplier of mobility services to both individuals and professional fleet customers, primarily through a well-established network of fuel and electric stations, convenience stores and travel centers, alongside a complementary top-tier fuels and oil-based lubricants distribution platform. The company has a network of more than 454 Shell service stations and 221 upa! and up!ta convenience stores in Chile, supplies over 68 service stations in Paraguay, and operates more than 53 Road Ranger travel centers in the United States.

In Chile, Enex is also a leading player in the distribution and commercialization of fuels and lubricants for various industries, such as mining, aviation, transport, construction, marine and forestry. In addition, it has a network of fast-charging points located in service stations in Chile.

Among other investments, Enex has a 50.00% stake in Asfaltos Conosur S.A., a bitumen storage and dispatch operator; and a 33.33% stake in SIAV LTDA, which provides fuel storage and supply services to aircraft at Santiago International Airport.

The Luksic Group Croatia is one of the largest and most successful hospitality investors in the Croatian tourism sector.

The Group's journey began in 1999, when Andrónico Luksic Abaroa made his first investment in Croatian tourism by acquiring the Grand Villa Argentina—an iconic hotel built in the 1920s and a historic landmark in Dubrovnik. In the years that followed, the Group expanded its presence with the acquisition of Plava Laguna, a leading hospitality company based in Poreč, Istria.

Today, the Luksic Group's operations are primarily concentrated in Istria and Dubrovnik—two of Croatia's most renowned tourist destinations. Over the past 25 years, the Group has grown its presence through a portfolio of tourism and real estate companies, including Adriatic Luxury Hotels, Plava Laguna, and Excelsa Real Estate.

These companies operate across Dubrovnik, Poreč, and Umag, encompassing a total of 29 hotels, 9 campsites, 10 apartment villages, and a range of exclusive luxury properties, such as the iconic Villas Agava and Sheherezade.

In addition, Excelsa Real Estate owns and operates the popular Dubrovnik Cable Car, which transports approximately 435,000 passengers annually, and manages a diverse portfolio of 10 commercial properties throughout Croatia.

# Plava Laguna

On January 1, 2018, Plava Laguna Poreč and Istraturist Umag merged to form the new Plava Laguna, significantly expanding the company's portfolio and operational footprint. Today, the company operates in Poreč and Umag—two of the most prominent tourist destinations on the Istrian peninsula.

Plava Laguna d.d., based in Poreč, traces its roots back to 1957 with the founding of a campsite hotel. Most of its hotels and facilities were developed during the 1970s, when the company became a pioneer of sports and recreational tourism in Croatia.

In 2000, the Luksic Group acquired a majority stake in Plava Laguna through Sutivan Investments Anstalt. A major milestone followed in 2014, with the acquisition of a majority stake in Istraturist Umag d.d.—one of the most significant transactions in the history of Croatian tourism. This acquisition added a company with a rich 50-year legacy and substantial accommodation capacity to Plava Laguna's portfolio.

The integration of Istraturist was completed on January 1, 2018, alongside a comprehensive rebranding initiative aimed at modernizing and revitalizing the company's image. As a result, Plava Laguna emerged as a leading force in Croatia's tourism sector, with a daily capacity of over 43,000 guests, spanning 19 hotels, 10 apartment villages, and 9 campsites.

Plava Laguna's "vacation playgrounds" in Poreč and Umag offer guests a wide array of services across hotels, apartments, and campsites. The portfolio spans comfortable, well-equipped 3- and 4-star properties, as well as premium offerings designed to deliver exceptional guest experiences. In 2023, Plava Laguna launched Plava Laguna Sport, a dedicated brand aimed at advancing the development of sports tourism in Istria.

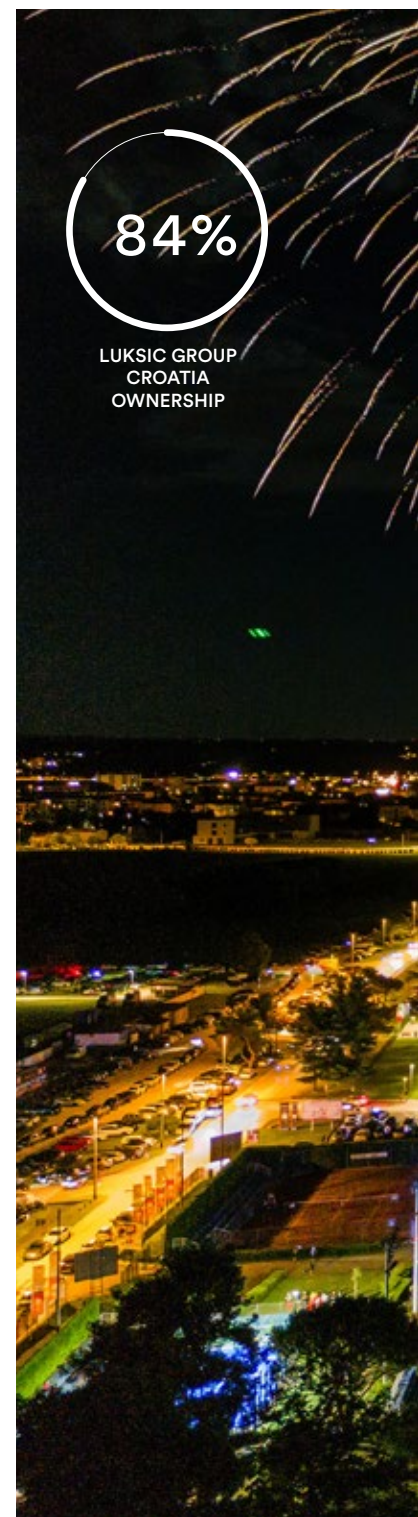

## Excelsa Real Estate

Founded in 2006, Excelsa Real Estate manages a diverse portfolio of commercial properties across Croatia and engages in a variety of real estate-related activities. Its most valuable assets are located in or near Dubrovnik's historic city walls, and include heritage properties such as the Pucić Summer Residence, Nautika, and Lučarica, as well as a parking facility adjacent to the Old Town.

In 2009, Excelsa undertook the restoration of the Dubrovnik Cable Car, originally built in 1969 and heavily damaged during the Homeland War (1991–1995). Following extensive reconstruction, the cable car reopened in July 2010 and was incorporated into Excelsa's real estate operations. As of December 2024, it has transported over 5.3 million passengers, becoming a signature attraction of the city.

Today, Excelsa Real Estate manages a wide range of assets, including three historic buildings in Dubrovnik, a parking area near the Old Town, drydock facilities in suburban Dubrovnik, a commercial building within Diocletian's Palace in Split, retail spaces in Dubrovnik and Šibenik, and approximately 35,000 m<sup>2</sup> of land in the Konavle region, located 35 km south of Dubrovnik.

An essential part of the legacy left by Andrónico Luksic Abaroa was his philanthropic activity. Convinced that it was his duty to contribute to the development of the social needs of his country, from the 1960s onwards Mr Luksic started creating institutions focused on helping underprivileged children and young people in Chile.

His children and grandchildren have not only taken over control of the foundations he set up, but also extended the work he began, which is now spread across six social benefit organizations. These make their contributions to society in various areas: entrepreneurship, justice, health, sport and especially education. This latter was an area chosen originally by the founder and is where the family now devotes its greatest efforts.

Four organizations presently contribute towards different stages of the education process. *Fundación Luksic*, *Fundación Educacional Luksic*, *Fundación Educacional Oportunidad*, and the initiative *Luksic Scholars* together cover a range of activities from preschool education to postgraduate studies. These activities encompass primary schools in rural areas, secondary schools in underprivileged neighbourhoods, technical and vocational training institutions and even some of the world's best universities, with which the family has special agreements.

Another three foundations contribute to the country in other action areas. *Fundación Guillermo Luksic Craig* concentrates on health and

infancy; *Fundación Impulso Inicial* on entrepreneurship, health, education and sports; and *Fundación Amparo y Justicia* on helping people who need support and legal assistance in cases of sexual assault resulting in death.

The family's history and roots have also played a role in the charitable work that the Luksic family has chosen to support. For instance, the Croatian origins of the founder influenced the support given to *Instituto Agrícola Pascual Baburizza*, located in the town of Los Andes, near Santiago, which was originally set up by a prominent Croat who lived in Chile.

The birthplace of Mr Luksic and his children - the region of Antofagasta – has prompted them to undertake a number of social initiatives related to these origins. These include the building of the new Teletón institute for the rehabilitation of children with a disability in Antofagasta and the Norte Grande area of Chile and the renovation of *Parque Brasil* in the heart of the city. Furthermore, *Fundación Luksic* works with various secondary schools in underprivileged areas in this part of the country.

The Luksic family has also been a frequent and important collaborator in large-scale charitable fundraising campaigns in Chile, a country that has often been hit by natural catastrophes demanding transversal solidarity and aid.

# Fundación Luksic

---

*Fundación Luksic is the first and oldest of the Luksic family's foundations. The family's philanthropic work began with Andrónico Luksic Abaroa in the 1960s and was formalized in the year 2000 when the foundation was established. Since 2020, the organization has brought together the work of Fundación Educacional Luksic, Fundación Impulso Inicial and Fundación Luksic Scholars, in addition to being the vehicle for any of the family's donations. This makes Fundación Luksic the Luksic family's principal philanthropic organization.*

*Fundación Luksic's is at the service of Chile, contributing to the country's development. Our work focuses on developing essential skills through programs tailored to different life stages, from childhood to adulthood. Additionally, we address key national challenges, including emergency response and conservation efforts.*

We **design and implement evidence-based programmes** that enhance the development of socio-emotional competencies and skills in individuals at different stages of life. With the aim of refining

and ensuring the quality of our social programmes, we evaluate our initiatives at four key stages, in coherence with the programme's respective theory of change. Furthermore, to guarantee that programmes are implemented efficiently and effectively, we operate under a continuous improvement model that focuses on delivering a quality service and experience to our beneficiaries.

Historically, *Fundación Luksic* has supported programmes in **education**. We strongly believe that through education, we can transform the life paths of students at both the personal and professional level. To this end, we have developed a programme for fourth-year students in technical and vocational secondary schools, called *Aspiraciones Sobre el Futuro*, which identifies the main barriers they face when accessing higher education. The aim is to support them in making informed decisions and thus enhance their life trajectories, and this has so far been implemented in +590 schools, reaching over 160,000 students. To complement this, we also work with teachers, school administrators and other education professionals to enhance language and mathematics

learning for students in the first two years at 31 technical and vocational secondary schools (*Redes Educativas para la Mejora de Aprendizajes*). In 2024, we launched the Luksic Scholarship: More Women in STEM programme, which provides financial support to 100 women from various communities across Chile who are enrolled in technical STEM at professional institutes or technical training centers.

Additionally, The *Fundación Educacional Luksic* supports the Instituto Agrícola Pascual Baburizza (IAPB), a private, subsidized vocational secondary school founded in 1941 to encourage the advancement of arts and sciences related to the agricultural industry.

To complement our work in education, we also use **sports** as a mechanism for developing socio-emotional skills and prosocial competencies in children and adolescents. In this sphere, we run after-school football and hockey programmes with the aim of promoting physical activity, encouraging healthy lifestyles, fostering teamwork, and developing parenting skills within families. In 2024, over 1400 boys and girls participated in these programmes.

Furthermore, to contribute to the development of our country, we also support **entrepreneurship** programmes to enhance entrepreneurial skills, enabling individuals to increase their sales and grow their businesses. We implement three programmes aimed at entrepreneurs with micro and small businesses throughout Chile. The *Impulso Chileno* programme, which was first launched in 2018, has awarded more than 900 entrepreneurs with academic support, one-to-one mentoring and funding of between three and five million Chilean pesos to advance their businesses. In 2021, we designed a spin-off of this programme to cater specifically for women entrepreneurs (*Despega Mujer*), which has so far benefitted 480 women in twelve regions with access to training, mentoring, and learning circles, as well as funding. In addition, we have an agile programme that enables us to provide tangible support in a short time frame to entrepreneurs in need of small items of machinery and tools (*Impulso Inicial*). Since its inception, it has supported over 24,000 entrepreneurs.

Through our international education area, we provide access to cutting-edge training programmes at international institutions like the universities of Harvard, Columbia, Stanford, Oxford, and Edinburgh, MIT, Babson College and LSE and Sciences Po. Additionally, we facilitate the transfer of knowledge to Chile and its regions through certifications aligned with the training needed for the country's development. Over 2,000 people have completed an international programme funded by the Foundation over the past 20 years.

Lastly, we also support major causes that mobilize the country, such as the annual *Teletón* for children with a disability, which the family has been supporting since 2014 by funding the establishment of the new Institute in Antofagasta. Similarly, we have also developed the capacity to support the country's response to the natural disasters that Chile frequently experiences, collaborating with institutions, communities, and individuals to provide specific and major contributions.

In 2025, the organization incorporated two new areas: Infancy and Conservation. The first launched a program called "Conversemos Mamá" that provides practical tools and everyday strategies to promote neurodevelopment, encourage healthy parenting, and ensure the well-being of mothers and children up to two years old. The Conservation area, meanwhile, aims to preserve and protect natural heritage to leave a lasting legacy for future generations through concrete conservation strategies. These include scientific research and unique spaces open to the community.



# Fundación Guillermo Luksic Craig

Established in line with Guillermo Luksic Craig's strong commitment to Chile's development, the Foundation was created with a clear purpose: to build effective partnerships that support the country's most vulnerable communities. Inspired by the legacy of Ena Craig de Luksic, today the Foundation collaborates with a wide range of organisations to promote opportunity, drive social impact, and contribute to long-term, sustainable change. Its main current focus is the management of a care home for children, where it provides a safe and supportive environment for those in need.

Following the early death of Guillermo Luksic at the age of 57, his five children renamed the institution after their father. Right from its inception, it has focused on offering help to those most in need. The organization has worked on various projects including educational, cultural and health-related initiatives.

The *Guillermo Luksic Craig* foundation is known for working very closely with the *Luis Calvo Mackenna* children's hospital, participating in a number of initiatives. It collaborated in the construction of the "*Consultorio Ena Craig de Luksic*" a building used mainly for paediatric cardiology and bone marrow transplants. It has also supported the implementation of medical equipment in several medical corporations, policlinics, and regional hospitals.

The foundation has supported a number of educational and cultural initiatives, including the restoration of the church in Ovalle, the financing of the film "*El Vuelo de Manutara*", the construction of a gymnasium on Easter Island and the awarding of scholarships for children at the Choshuenco school. The foundation's current chairwoman, Antonia Luksic Puga, and its vice chairwoman, Isidora Luksic Prieto, are both daughters of Guillermo Luksic Craig and granddaughters of Andrónico

Luksic Abaroa. Under their guidance, the institution has acquired a new focus: the setting up and management of a care home for ill children from outside Santiago, who need a place to stay during their numerous treatments. Inaugurated in March 2019, the home provides comprehensive care for 11 children and their companions. Each person has their own room and receives food and transportation to medical centres. In addition, there are opportunities to take part in cultural and educational activities held at the care home for children.



# Fundación Amparo y Justicia

*For 27 years, Fundación Amparo y Justicia has worked to facilitate access to justice and psychosocial support for families who have lost a son or daughter due to a sexual assault resulting in death. Building on this experience and their work with families, they have influenced the development of public policies that enable institutions to have the necessary conditions to guarantee the effective exercise of the rights of children and adolescents who are victims of sexual crimes.*

Amparo y Justicia dates back to 1998, when a 5-year-old girl was sexually assaulted and murdered two years earlier in the city of Talcahuano. That same year, three other people were victims of the same crime in other cities of Chile. Due to the absence of public institutions with the expertise to adequately respond to the families of these victims, and the resulting vulnerability of these families, Andrónico Luksic convened a group of renowned solicitors to provide legal representation and psychosocial support free of charge.

That was the beginning of *Fundación Amparo y Justicia*, the first organization in Chile to provide comprehensive assistance to families who have lost a daughter or son to murder involving sexual assault. Since that year, the foundation has accompanied 50 families in different parts of Chile, providing legal, psychosocial and communication support.

Since 2007, *Amparo y Justicia* has also advocated in different ways for public policies to help prevent secondary victimization of children and adolescents. To this end, the foundation supported Law 21.057 on Videotaped Investigative Interviews, encouraging relevant criminal justice institutions to work in coordination, and providing technical advice during the parliamentary discussion and processing of the law and its subsequent implementation. This process began in late 2019 and continues to this day.

Also, *Fundación Amparo y Justicia's* participation in Parole Commissions, representing the families of victims and advocating for the full enforcement of sentences for child rapists and murderers, provided the expertise needed to promote regulatory changes that culminated in a new law in 2023. This legislation not only strengthened the requirements for granting parole to those convicted of serious

crimes but also, for the first time, granted victims the right to be heard during the parole process.

Currently, the organization is addressing a new challenge: cases of sexual assault in the context of homicide that remain unrecognized, as well as reports of such crimes that fail to result in convictions due to deficiencies in investigative processes. To address this urgent issue, *Fundación Amparo y Justicia* is working to enhance the prevention and investigation of cases involving the homicides of children and adolescents.





# Fundación Educativa Oportunidad

The purpose of this foundation, created by Andrónico Luksic Craig in 2006, is to promote the education and development of children and young people from early childhood, innovating and working in collaboration with other organizations.

The foundation implements three programmes. A Good Start is a professional development programme for educational teams and school leaders that aims to improve the quality of childhood education. In 2024, this programme has been implemented in five municipalities and 16 institutions in the Cardenal Caro Province in the O'Higgins Region, benefiting 488 children.

Meanwhile, the A Good Start Improvement Network, which includes schools that have taken part in the programme, aims to maintain the improvements and promote innovation with a focus on learning. Today, the network is present in eight municipalities and one Local Public Education Service Colchagua which covers four municipalities, benefiting 3,796 children in the O'Higgins Region.

We Learn is a professional development programme for English teachers and school leaders which promotes learning English from early childhood. In 2024, the programme was implemented in 23 schools from Pucón and Villarrica in the Araucanía Region, reaching a total of 1,636 students from early years education to primary school.

The We Learn Improvement Network brings together schools that have been part of the program and is committed to maintaining progress while fostering innovation centered on student learning. In 2024, the network operated in two municipalities and within one Local Public Education Service, reaching 21 institutions and positively impacting 1,536 children.

Finally, the Attendance programme provides tools and strategies to management teams and educators at public schools and kindergartens aimed at promoting and increasing the class attendance of children in preschool education. The programme currently covers 16 regions

of Chile, 22 schools, 1,377 kindergartens, reaching a total of 85,795 children. Among the main achievements of the programme are the transfer of the attendance model to the National Board of Kindergartens (JUNJI) and a study of the impact of attendance strategies to enable their effectiveness to be assessed.

The foundation also has a learning transfer area designed to share the lessons learned over the years of implementing the A Good Start, We Learn, and Attendance programmes. All of the resources and courses can be found at [www.oportunidadenlinea.cl](http://www.oportunidadenlinea.cl).

Additionally, the foundation offers continuous education programmes in areas such as interactions, and a leadership diploma for continuous improvement in early childhood education.

During 2024, almost 3,000 professionals received training from the foundation, and more than 6,000 people started courses on its platform.

# Fundación Te Apoyamos

*Fundación Te Apoyamos is the most recent charitable institution set up by Andrónico Luksic Craig. It began operating in September 2022. Its purpose is to help people or groups that are going through a difficult time financially or socially and who need real assistance to keep going.*

*Fundación Te Apoyamos was set up to respond to the many different requests for help that its founder receives and provide timely, empathetic and efficient assistance that can generate an improvement in people's quality of life. To achieve this, a thorough assessment process is undertaken to gain an in-depth understanding of each applicant's needs and prioritize aid according to the vulnerability and urgency of each case.*

The organization is currently focused on six priority areas: Education, sports, culture, health, entrepreneurship and social emergencies.

Since its creation, *Fundación Te Apoyamos* has provided over 7,000 instances of support to people and organizations throughout Chile. It made contributions with a high impact on the community, including remodelling and improving the infrastructure of health and education facilities and donating vital healthcare equipment.

It has also made a significant contribution to sports, supporting more than a thousand sports organizations and individual athletes so they can realize their dreams.







# Fundación La Tapera

La Tapera is a community-based conservation project that was started in 2013 by Paola Luksic, her husband, Oscar Leria, and their five children. In the municipal district of Tortel in the Aysén Region, the family created a space dedicated to protecting the local natural heritage centred around the conservation of two emblematic species: the South Andean deer (*Hippocamelus bisulcus*, known locally as huemul) and *Pilgerodendron uviferum* (a local variety of cypress tree known locally as ciprés de las Guaitecas).

La Tapera Park is located on the Chilean coast, around 60km (37 miles) to the south-west of Caleta Tortel. It boasts a wide range of landscapes, with many paths, lookout points and hidden corners to explore.

The main objective of the park is to develop and foster initiatives that support the conservation and protection of the local ecosystem through scientific research, environmental education and integrating the neighbouring communities.

# Santuario La Fusta

The *La Fusta Reserve* is a recovery and conservation project in the municipal district of Lonquimay in the Araucania Region. The goal is for La Fusta to become Chile's foremost private project for conserving and protecting the Chilean native tree known as the monkey puzzle tree (*Araucaria Araucana*), a species of unrivalled beauty and great natural heritage value that was declared a Natural Monument in 1990 and is also regarded as a sacred tree by the Mapuche-Pehuenche people.

The *La Fusta Reserve* has been implementing this project to protect native forests since 2012. It covers an area of 9,000 hectares (22,239 acres), of which 4,600 hectares (11,367 acres) are monkey puzzle forest.

At the moment, the project is seeking to recover and reforest 3,000 hectares (7,413 acres) that were destroyed in a wildfire in 2010. During the 10 years since it began, the project has planted 369 hectares (912 acres) of lenga beech trees (*Nothofagus Pumilio*) and 51.5 hectares (127 acres) of raulí beech trees (*Nothofagus alpina*), oaks (*Nothofagus obliqua*) and Dombey's beech trees (*Nothofagus dombeyi*, known locally as Coihue). It has also been reforested with 7,500 monkey puzzle trees, as part of a plan to plant 25,000 new examples of this species over the coming years.
